Please find the following price to complete dredging work within the lake adjacent to the above address. EMC plans to dredge and remove approximately 200 yards of sand sediment from the shallow portion of the lake. For disposal, this material will be dredged into geo tubes being re-purposed as erosion control for the entire lake bank. EMC will install 1 permanent geo tube for erosion control purposes and a sacrificial geo tube for grading purposes along approximately 550' of lake bank. Once dredging is complete the geo tube will be graded over with sand from the sacrificial geo tube. Sod will then sod be laid and pinned over the geo tubes. The community will be left with a properly dredged lake that increases the storm water capacity and a manicured shoreline resistant to future erosion.

No heavy equipment or disturbance to the surrounding landscape will be necessary. All work will be performed from the lake. Access will only be needed to back the dredge into the lake and remove the dredge when complete.

\$38,500 Lump Sum - Dredge approximately 200 yards of sand material utilizing geo tubes for disposal.

5,500 sq.ft. of St Augustine Sod Installed & Pinned @ \$1.50/sq.ft. - \$8,250.00 Unit Price - \$1.50/Sq.ft.
